The ZOOM meeting was called to order at 3:40 p.m. Frank Yee welcomed everyone and introduced the special guest non-profit attorney Deborah Buyer.

The Governance Committee explained that due to the COVID-19 this past year, it was necessary to amend the Chinatown DMA's By-Laws by allowing the board to conduct business either by telephone or video conference, and to approve previous board meeting minutes and actions taken by the board during previous months. The Committee with the help of a non-profit attorney and former SBS counsel drafted the amendment to the By-Laws and Unanimous Written Consent, they were emailed, reviewed and approved by all the voting members.

Also presented to conform to the Non-Profit Revitalization Act were the updated CDMA Annual Disclosure and Conflict of Interest policies.

Motion to approve the Chinatown DMA Annual Disclosure and Conflict of Interest Policy passed unanimously.

Also presented were previous minutes of meeting and other documents to be officially approved.

Motion to approve the March 12, 2020 minutes of meeting and all actions taken by the board passed with one abstention.

Motion to approve the June 4, 2020 minutes of meeting and all actions taken by board passed unanimously.

Motion to approve the September 3, 2020 minutes of meeting with the correction of typo Ian "Chan" (last name was mis-spelled) and all actions taken by the board passed with one abstention.

The NCheng accounting team continued with the financial report with a surplus due to savings on the hiatus of programs, clean street budget and personnel expenses, but increased in COVID-19 expenses to support to local eateries. Also presented for all board members to review were the Audit Committee approved FY20 Draft Audited Financial Statement and Communication Letter.

Wellington followed with a PowerPoint presentation showing the damage assessments from COVID-19. However, the BID never stop providing support services to the community by distributing PPE, sandbags, reflector tapes, lending fixtures, portable heaters for outdoor dining, outreach with update outdoor dining regulations and COVID-19 information, grants and loan opportunities, guidance workshop seminars, etc..

Board members were concern and asked if there are any government help or tax relief to property owners, representative of Assembly Member Niou informed that AM Niou just introduced two acts: 1) Rent and Mortgage Cancellation Act and 2) COVID-19 Small Business Recovery Lease Act among others in queue.

The Clean Street budget and personnel was briefly discussed as Chinatown is returning to normal and extra personnel is needed to keep the district clean, the board instructed Streetplus to adjust their working schedules.

The Nominating Committee Chair reported that the BID Nomination Notice were posted in our social media well in advance since August. Philip Lam due to his busy schedules resigned as board member with church rebuilding activities, the Chair on behalf of the board thanked him for all his supports since the BID formation. The BID received only one application of Mr. James T. Tang property owner of Hwa Yuan Szechuan, Mr. Kenneth Leung as the designee for Lin Sing Association and Mr. David J. Louie Jr. as the designee for Community Board #3 Manhattan.
